



QATSIF Scholarship Student Application

This form must be fully completed and returned to your school before the closing date – **Friday 29 August 2025**.

Student Eligibility Criteria

An eligible QATSIF Scholarship Applicant:

- is a person of Aboriginal and / or Torres Strait Islander descent who identifies as an Aboriginal and / or Torres Strait Islander person, is accepted as such by the community in which they live and reported as such in the school's Federal and State Government Census Data.
- is an Australian citizen and resident of Queensland.
- is enrolled at this school as an Aboriginal or / and Torres Strait Islander student. **Students who have identified following their initial enrolment at the school may be asked to provide a Confirmation of Aboriginality to QATSIF with this application. (Note 1.)**
- intends to undertake and complete their *Queensland Certificate of Education (QCE)*, *International Baccalaureate (IB)* or *Queensland Certificate of Individual Achievement** (QCIA) during the school years 2026-2027 and has the ability and the school's confidence of fully completing their QCE, IB or QCIA* by Year 12 Graduation.
- has current school attendance of 85% or more.
- is under the age of 35.
- is currently achieving A-C in English and a C or higher in every current grade subject.
- demonstrates effort and behaviour of a C or above.
- participates in school activities which enhance their Aboriginal and/or Torres Strait Islander cultural identity.
- demonstrates willingness to fully participate in the life of the school and be a worthy role model of behaviour for other students.

Please Note:

* QCIA – only for students counted in the NCCD (Nationally Consistent Collection of Data on School Students with Disability)

1. QATSIF relies on each school's official Census data for the confirmation of Aboriginality for QATSIF Scholarship applicants. QATSIF advises schools to remind families of their obligations in terms of authenticity. **In situations where a student identifies as Aboriginal or Torres Strait Islander after school enrolment, Confirmation of Aboriginality documentation may be required.** Please note that increasingly, Universities require Confirmation of Aboriginality documentation as part of their enrolment process.
2. Any approval of this application for a QATSIF Scholarship is conditional only and subject to QATSIF receiving written confirmation of the following matters:
 - a. the applicant is enrolled in, and has commenced attendance at, a Queensland Secondary School (the "Receiving School") for the purpose of completing their QCE, IB or QCIA*.
 - b. the Receiving School is confident that the applicant has the ability to fully complete their QCE, IB or QCIA* by Year 12 Graduation.
 - c. the Receiving School agrees to enter into a funding agreement with QATSIF.

Written confirmation of these matters is to be provided by the Receiving School and signed by the Principal of the Receiving School.



Application of QATSIF Scholarship Funds

QATSIF Scholarships of up to \$1000 per student per year are awarded via the student's senior school to assist families and provide for the costs of senior education. If successful, the school and family must dialogue and agree to the specific areas of expenditure.

Computer hire levy / IT device purchase

Schools, QATSIF students and their parents / carers need to be aware that QATSIF:

- is willing to contribute a maximum of \$300 (across the entire 2-year QATSIF Scholarship period) toward the costs of either a computer hire levy or the purchase of an IT device where the use of such a device is approved by the school and necessary to enable the student to complete curriculum activities.
- will not fund repairs, damage or replacement of these IT devices and will not contribute to any costs associated with this.
- directs that any IT devices hired or purchased are for the exclusive use of the individual QATSIF Scholarship student and remain the property and responsibility of the hirer and / or student.
- is not responsible for either the inappropriate or illegal use of these IT devices.
- supports that all school rules, appropriate usage guidelines and school agreements apply to QATSIF students just as they do to all other students.
