Distance Education Fee

Home based distance education students are charged a distance education fee under s.52 of the [Education \(General Provisions\) Act 2006 \(Qld\)](#) (the Act) unless they are exempt from payment or obtain a waiver of the fee.

Distance Education Fee Exemption

Home based students are exempt from payment of this fee if they are enrolled in a program of distance education at a State School and satisfy the criteria in relation to one of the following categories within the [Education \(General Provisions\) Act 2006 \(Qld\)](#) :

Living in a remote area - s.53(1)(a)

Medical condition – s.53(1)(b)(i&ii)

Itinerant lifestyle – s.53 (2)

Exclusion – s.53(1)(d) & (e)

Carer responsibility – s.53(1)(f) & (g)

Mature age student – s.53(1)(i)(i&ii)

Distance Education Fee Waiver

Home based students who are enrolled in a program of distance education and are not exempt from payment, can apply for a full or partial *waiver of the fee under s.54 of the Act*. The application must include sufficient information for the Principal to make an informed decision and the waiver applies only to the school year for which it is granted.

The Principal of Cairns School of distance education may waive payment of the fee if satisfied the student is:

- Undertaking Distance Education and would suffer a significant educational disadvantage if the person were not able to continue in the program, and
- Payment of the fee would cause financial hardship to the person liable to pay it.

Distance Education Fee Refund

A home based distance education student can apply for a *part refund of the enrolment fee under s69A* of the [Education \(General Provisions\) Regulation 2006 \(Qld\)](#).

Students must request the refund before the end of the first semester, by written application to the school Principal stating the reason/s for the application and the date their enrolment ceased.

The fee may be partially refunded if, due to a change in their personal circumstances, the student is no longer enrolled in the program of distance education. Personal circumstances may include a change in family circumstance that necessitates a move in residence to another location.

Refunds will be determined by the Principal and apply to the Distance Education Fee only.

Please note: Distance Education goods and resources do not commence until:

- Payment of the \$300 Security Deposit has been received, and
- Payment of resource invoices (i.e. SRS) has been paid and received in full or,
- The first instalment of an approved payment plan &/or Centrepay has been received.

Student Resource Scheme & Textbook Resource Allowance

Student Resource Scheme Participation Fee – Prep and Years 01 – 12

In accordance with the *Education (General Provisions) Act 2006*, the cost of providing instruction, administration and facilities for the education of students enrolled at State Schools who are Australian citizens or permanent residents, or children of Australian citizens or permanent residents, is met by the State.

Parents are directly responsible for providing textbooks and other personal resources for their children while attending school. In recognition that these costs can be high, the school operates a Student Resource Scheme (the “scheme”) that enables a parent to enter into an agreement with the school that, for a specified annual participation fee, provides for the temporary use by the student of prescribed textbooks and/or other resources, and/or the purchase of consumables and materials for the student.

Textbook and Resource Allowance – Government Allowance – Years 07 – 12

The Queensland Government provides financial assistance to parents of students in Years 7 to 12 or of secondary education age, attending State and approved Non-State Schools, to offset the costs of textbooks and other resources. Assistance is provided in the form of a Textbook and Resource Allowance which is paid once a calendar year through the school. Parents have the option to receive the allowance directly from the school or as an offset of fees associated with participation in the school's Student Resource Scheme. This option is made available to each parent annually by the school.
